FEMA and USDA Disaster Declarations

Both FEMA and the USDA have declared disasters for the July flooding. This means additional funds are available for disaster recovery. More information on receiving assistance is below.

Guidance for applying for assistance:

- 1. Apply to insurance first (homeowners, renters, car, flood, etc.).
- 2. Gather all required personal documentation (identity, proof of property ownership and residency).
- 3. Gather all disaster damage-related documentation (insurance denial letter, receipts for clean-up supplies and contractors, contractor estimates, photos of all damage, etc.) for your FEMA case.
- 4. Check 'home damage' at the beginning of your FEMA application if you have disaster-related damage outside your home (driveways, culverts, bridges, external retention walls, etc.) in order to trigger a damage inspection.

The July 29th-30th storm has yet to be declared a disaster. People affected by this storm can register with FEMA, but will not be approved for assistance until that declaration is approved.
